Support at Home Consumer Contributions

Support at Home program Consumers may be required to contribute to the Services they receive, by paying a Service Contribution at the rates prescribed by the Aged Care Act and set out in their Services Australia assessment (if any). The Consumer's Service Contribution Rate depends on their means and may change over time.

Support at Home Service Contribution Rates:	Clinical Care Supports	0%
	Independence Supports	5% - 50%
	Everyday Living Supports	17.5% - 80%

If the Government assesses that a Support at Home Consumer is eligible for a Fee Reduction Supplement, this will reduce the Service Contributions they need to pay.
